

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to TidesofBridgeside.com and Tides at Bridgeside Square and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Tides at Bridgeside Square include TidesofBridgeside.com and Tides at Bridgeside Square. Collection of your Personal Information
